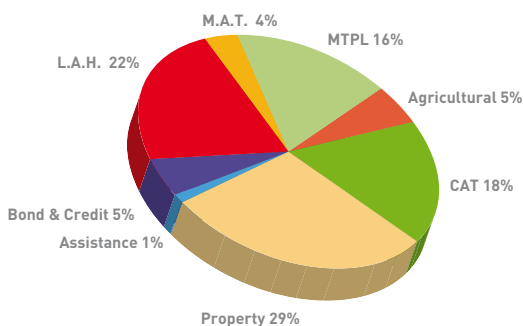

Distribución por Línea de Negocio (E Primas Brutas Año Suscripción 2015)

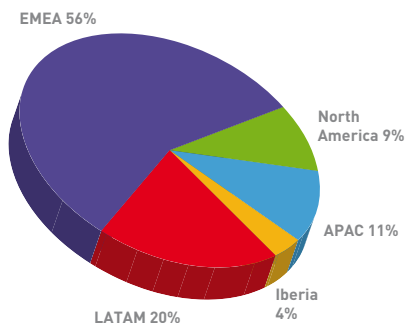
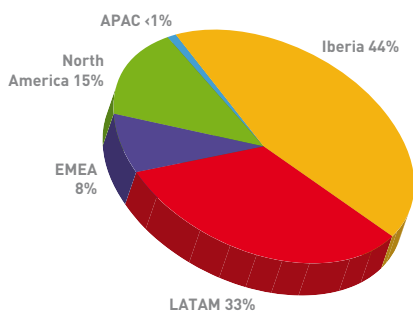


→ Distribution by Geographic Area (E GWP U/W 2015)
